



Programs/Initiatives

- High Intensity Drug Trafficking Area (HITDA)¹⁰
Designated in 1998, the Milwaukee HIDTA is responsible for the following counties in Wisconsin: Kenosha, Milwaukee, Racine and Waukesha.
- Wisconsin State Council on Alcohol and Other Drug Abuse¹¹
The State Council on Alcohol and Other Drug Abuse was created in the Office of the Governor in August 1970 to provide leadership and coordination regarding alcohol and other drug abuse issues confronting the state.

Crime and Drug-Related Crime

- During 2007, the Drug Enforcement Administration (DEA) made 232 drug arrests in Wisconsin.¹²

- There were 165 murders known to police in Wisconsin during 2006, a 20.3% decrease from the 207 murders known to police during 2005.¹³

- There were 23 juvenile and 141 adult arrests for murder in Wisconsin during 2006.¹⁴

- There were 4,203 juvenile and 15,605 adult arrests for drug possession in Wisconsin during 2006.¹⁵

- Approximately 8.3% of the murders, whose circumstances were known to law enforcement, in Wisconsin during 2006 were drug-related.¹⁶

Drugs

- Cocaine¹⁷
Powder and crack cocaine are both widely available in Wisconsin and are of particular concern in eastern and central Wisconsin.
- Heroin¹⁸
High levels of heroin purity in Wisconsin give users the option of snorting the drug rather than injecting it, an option that may appeal to younger users.
- Marijuana¹⁹
Marijuana remains the most readily available and most widely abused drug throughout Wisconsin.
- Methamphetamine
Methamphetamine production and use are expanding from the neighboring states of Iowa and Minnesota into northwestern and southwestern Wisconsin.²⁰ Much of the methamphetamine available in Wisconsin has come from Mexico, transported to Wisconsin from California and other Southwest Border states.²¹
- Pharmaceutical Diversion²²
The use of diverted controlled substances in Wisconsin continues to be a problem. The most commonly diverted controlled substances from the licit market are Ritalin, Vicodin, hydrocodone products, OxyContin, other oxycodone products and benzodiazepines.
- According to 2004-2005 data from the National Survey on Drug Use and Health (NSDUH), approximately 346,000 (7%) Wisconsin citizens (ages 12 or older) reported past month use of an illicit drug.²³

- Approximately 1.5 million (31.73%) Wisconsin citizens reported that using marijuana occasionally (once a month) was a “great risk”.²⁴
- Additional 2004-2005 NSDUH results indicate that 134,000 (2.88%) Wisconsin citizens reported illicit drug dependence or abuse within the past year. Approximately 82,000 (1.78%) reported past year illicit drug dependence.²⁵

Juveniles

- According to 2004-2005 NSDUH data, approximately 50,000 (11%) Wisconsin 12-17 year olds reported past month use of an illicit drug.²⁶

- Approximately 37% of Wisconsin high school students surveyed in 2005 reported using marijuana during their lifetime.²⁷

- Approximately 10% of Wisconsin 12th graders surveyed in 2005 reported using cocaine at least once during their lifetime.²⁸

Enforcement

- As of October 31, 2006, there were 18,111 full-time law enforcement employees in Wisconsin (13,038 officers and 5,073 civilians).²⁹
- Wisconsin Department of Justice, Division of Criminal Investigation: Narcotics Bureau³⁰
The activities of the Narcotics Bureau include providing investigative assistance to local law enforcement and initiating independent drug investigations.

Trafficking and Seizures

- Three types of organizations are responsible for most of the transportation and wholesale distribution of drugs in Wisconsin: Mexican drug trafficking organizations that transport cocaine, marijuana and methamphetamine; Nigerian criminal groups that distribute Southeast Asian heroin; and Dominican criminal groups that distribute cocaine and South American heroin.³¹
- Federal agencies in Wisconsin seized 66,103 dosage units of MDMA during 2007.³²

- During 2007, there were 4 methamphetamine laboratory incidents in Wisconsin reported by the DEA and state and local authorities.³³

- During 2006, more than 8,000 cultivated marijuana plants were eradicated and seized in Wisconsin as part of the DEA's Domestic Cannabis Eradication/Suppression Program.³⁴

Courts

- Drug Courts³⁵
As of April 2007, there were 9 drug courts in Wisconsin that had been operating for at least two years, 6 that had recently been implemented and 6 that were being planned.
- During FY 2006, 42.8% of the Federally-sentenced defendants in Wisconsin had committed a drug offense. Approximately 39% of these drug cases involved crack cocaine.³⁶

Corrections

- On January 25, 2008, the adult institutional population in Wisconsin was 22,242.³⁷
- The adult community corrections population in Wisconsin was 72,473 on August 31, 2007.³⁸
- The Wisconsin Division of Juvenile Corrections population was 579 on January 25, 2008. The Juvenile Field Operations population was 240 at that time.³⁹

Consequences of Use

- According to the El Paso Intelligence Center, there was 1 child affected by methamphetamine laboratories in Wisconsin during 2007.⁴⁰

Treatment

- During 2006, there were 23,050 admissions to drug/alcohol treatment in Wisconsin.⁴¹ There were 25,566 such treatment admissions during 2005.⁴²

- According to 2004-2005 NSDUH data, approximately 122,000 (2.64%) Wisconsin citizens reported needing but not receiving treatment for illicit drug use within the past year.⁴³
